



**2022 Municipal and School Board Elections**  
**Notice of Nomination For Office**  
*Municipal Elections Act, 1996 (c.32)*

Municipal and School Board Elections will be held on Monday, October 24, 2022. The term of office will be November 15, 2022 to November 14, 2026.

Notice is hereby given that as of Monday, May 2, 2022, nominations may be filed in person, or by agent during regular business hours, **by appointment only**, in the Clerk's Office between May 2, 2022 and August 18, 2022 and on Friday, August 19, 2022 (Nomination Day) between 9:00 a.m. and 2:00 p.m.

Nominations must be submitted on the prescribed form (Form 1) and accompanied by the prescribed nomination filing fee of \$200 for the Head of Council and \$100 for all other offices. The filing fee is payable by cash, certified cheque, money order or electronic payment if specified by the Clerk. The Nomination must also be accompanied by an Endorsement (Form 2) signed by 25 eligible Tecumseh electors.

Nomination Papers must be filed with the respective Municipal Clerk of the municipality for which a person is seeking office before accepting contributions or spending money for their campaign.

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday,

August 24, 2022, between the hours of 9:00 am and 2:00 pm and such additional nominations, if required, are to be filed in the offices of the Clerk.
